Business Overview & Background

The Northern Michigan Mutual Aid Dive Team #3 is made up of Divers from 4 Counties in Northern Michigan. These Divers respond to incident throughout the State of Michigan to recover property and victims and investigate crimes (including terroristic events). In Northern Michigan, the waters are usually cold, and that is where the dry suits are used. The dry suits protect the divers from the frigid waters, and allow them to stay in the water over a greater period of time.

Detailed Specifications

The bid must include 13 dry suits for the Northern Michigan Mutual Aid Dive Team #3. The dive suit needs to meet, or exceed, the specification of the DUI TLS Select Public Safety Dry suit, and include: Zip seals on wrists & neck, double layer in high wear areas for extra durability, front entry zipper, warm neck collar, rock boots and dry suit bag. Shipping and handling must also be part of the bid.

Terms and Conditions

All equipment supplied by the vendor shall have a warranty of not less than one year. All vendors shall include in their proposal the standard terms of warranty for the specified equipment and labor. Any deviation to provide a one year warranty, shall be clearly stated in the proposal.
