**MANISTEE COUNTY TRANSPORTATION DIAL-A-RIDE GENERAL OPERATIONS RENEWAL AND INCREASE**

Shall the County of Manistee, Michigan, increase the constitutional limitation on the total amount of general ad valorem taxes imposed upon real and tangible personal property for all purposes in the County of Manistee, Michigan, by one-half (1/2) mill (\$.50 per \$1,000 of taxable valuation) and levy the amount of one-half (1/2) mill (\$.50 per \$1,000 of taxable valuation) for a period of six (6) years (2021 – 2026, inclusive) for the general operating purposes of Manistee County Transportation Dial-A-Ride?

This is a renewal of the prior one-third (0.33) mill levy which expires in 2020 and a request for an increase of seventeen one hundredths mill (0.17) for general operation purposes of Manistee County Transportation Dial-A-Ride; if approved, it is estimated that the revenue generated by this proposal in the first year would be \$579,847.00. The revenues generated by this proposal will be disbursed to Manistee County Transportation Dial-A-Ride. A portion of the millage may be subject to capture by and disbursed to one or more tax increment financing entities, including the City of Manistee Downtown Development Authority, the Charter Township of Filer Downtown Development Authority and the City and County of Manistee Brownfield Redevelopment Authorities.
