PUBLIC COMMENT

None.

SHERIFF'S OFFICE ITEMS

Undersheriff Torrey presented the statistics for the month of July 2022. (APPENDIX A) Stats were steady for the month of July except for 85 hours of transport due to mental health matters.

Sheriff Gutowski indicated that there continues to be issues with mental facilities and placements. He recently visited Emergency Services in Muskegon and are looking at shields for active shooter responses and will be looking for funding through the Revenue

shields for active shooter responses and will be looking for funding through the Revenue Sharing Grant for the shields. The dive team has two new members. Sheriff Gutowski recently met with the new commander of Coast Guard Station Manistee and will be doing some cooperative training. The Sheriff's Office has Onekama Days and Copemish Heritage Days this weekend, which will keep staff busy. There is an active shooter exercise being held next month in Mason County.

CITY OF MANISTEE PUBLIC SAFETY ITEMS

Chief Glass, prior to 2017 the city was not involved in mental health transports. He indicated that not one agency alone can handle the volume of mental health matters today. The City Police Department is fully staffed at 13 officers. They recently received two new Chevy Tahoes.

Chief Glass will be attending a threat assessment meeting next month at Manistee High School. There is a great collaboration regarding truancy. There is already a plan in place to combat truancy within Manistee County Schools that they will be looking at to update.

Chief Cameron, the City Fire Department will be attending a training session at Manistee Township Fire Station on September 17th. The department is working with the West Shore Community College EMT program, there will be students riding along with his staff. One staff member is currently in the paramedic program through Munson Healthcare.

MICHIGAN STATE POLICE REPORT

Sheriff Gutowski gave an update that the detachment post in Kaleva is still in progress.

TRIBAL POLICE ITEMS

Director Medacco indicated that complaint volumes are similar to that of last year. His agency is looking to pursue State regulation legislative changes to allow tribal offices to be recognized as all other officers of other agencies. Tribal Police are monitoring ongoing issues with the construction at US31 and M55 and cars speeding through the casino parking lot.

MOBILE MEDICAL RESPONSE (MMR)

Amy Fairchild presented statistics for MMR. (APPENDIX D) There were 174 calls for EMS services. They have a couple medics completing the paramedic training with Munson Healthcare. They are hoping to get 7 staff members from the EMT academy being held in Cadillac. They currently have 5 EMTs enrolled in the WSCC paramedic program.

DNR

EMERGENCY MANAGEMENT COORDINATOR ITEMS

Mike Machen indicated that the HAMM Radio equipment has been moved to the Wiitala Rd & 9 Mile Rd location. They are currently reviewing equipment to see what is still useable from the move. At the end of September, they will be hosting an ICS 400 class. There is an active shooter exercise being held in Mason County next month that he will be attending.

JAIL ADMINISTRATOR ITEMS

Chris Baniki presented the July 2022 jail statistics. (APPENDIX B) The jail is averaging 34 inmates. On Monday, August 3, 2022, the Michigan Department of Corrections completed their audit and the Jail is 100% compliant. They are currently down two staff members and were down three corrections officers last week due to COVID-19. There have been no cases of COVID-19 recently within the jail, as everyone coming into the facility must test prior to entry.

9-1-1 DIRECTOR ITEMS

3-year statistics were available for review. (APPENDIX C) Mike Machen informed that the 911 Renewal Millage passed and keeps them funded through 2028. They are currently fully staffed. July complaints were down.


LOCAL REVENUE SHARING BOARD, CYCLE II APPLICATIONS

Lisa Sagala reminded everyone that Local Revenue Sharing Board, Cycle II Applications will be available on the County's website August 15th.


