The meeting was called to order at 5:00 P.M. Roll call was taken, and the Pledge of Allegiance was recited.

There was a motion by Mr. Henderson, supported by Mr. Grabowski, to nominate Jeff Dontz, the Manistee County representative as Vice Chair, close nominations and cast a unanimous ballot for the Manistee County representative for the position of 2023 Vice Chair. Motion carried.

There was a motion by Mr. Henderson, supported by Mr. Dontz, to nominate James Grabowski, the City of Manistee representative as Secretary, close nominations and cast a unanimous ballot for the City of Manistee representative for the position of 2023 Secretary. Motion carried.

There was a motion by Mr. Dontz, supported by Mr. Henderson, to nominate Kristyn Malkowski, as Recording Secretary, close nominations and cast a unanimous ballot for the 2023 Recording Secretary. Motion carried.

The Board next discussed establishing meeting dates, times, and locations for 2023/2024, pursuant to Article VI, Section 6.7 and 6.8 of the Revenue Sharing Bylaws, as amended. It was noted that the 2023 Cycle I grant application deadline has already been set for Friday, March 3, 2023, at 5:00 P.M.
