a. Fishbeck MT Plate Diner-Incentive Request

Matt and Tracy Catlin, owners:

- Lack of restaurant/gathering place in Arcadia
- Purchased old Big Apple Restaurant property
- Looking at mix use; restaurant on bottom, 2 upper floor apartments
- Arcadia has no sewer or water hook-up; must place own on property
- Small Business administration loan for commercial part

Mr. Szokola:

- Catilin's unable to fund about 35%
- Brownfield prefers 20%

Fishbeck; Logan Mulholland and David Stegink:

- Presented 4 model preliminary evaluation of financial incentives
- Housing part go through Brownfield
- Commercial redevelopment abatement; looking at 12-year abatement
- 5% fee can increase to 15%
- Model at 15-year plan, tax abatement 12 years, model has tax abatement included
- Looking to bridge gap so project is successful

Ms. Batzer entered the meeting at 6:16 pm.

- Brownfield can waive adopted range
- State landbank; good with provided plan, work plan compliant with the statute and requirements
- 3 parts; land tax, commercial abated tax, normal residential tax

Brownfield supports: 15% years, 10% plan

Next steps:

- Compile application document, owners' complete application
- Tentative Brownfield meeting October 12th at 6 pm to review and approve application
- Send to County Board and Arcadia Township for approval from both
- Brownfield, County Board, Arcadia Township must approve by October 31, 2023
