Land Use Permit Fee Schedule 2020-2021

Land Use Permit:

Simple Permits: RV camping, Fences, Signs ≤ 50 Sq ft *	\$35.00
Signs > 50 Sq ft, attached decks, unattached decks	\$250.00
≤ 1600 Sq ft Dwelling living space w/ attached garage (if any) built in conjunction with the dwelling	\$500.00
≥ 1601 Sq ft Dwelling living space w/ attached garage (if any) built in conjunction with the dwelling	\$1,000.00
Guest Houses	\$1,125.00
Detached accessory buildings ≤ 1200 Sq ft and Additions less than 25% of existing Sq footage to such structures**	\$250.00
Detached accessory buildings ≥ 1201 Sq ft and Additions less than 25% of existing Sq footage to such structures**	\$500.00

Additional Fee if Project Includes Any of the Following: **\$125.00**

- Is an unusually Complex new dwellings*
- Additions enlarging existing dwellings or structures ≥ 25% of the existing Sq footage
- Covered Decks
- All construction in High-risk or Critical Dune areas

Special Use Permit: **\$700.00 + Costs******

• Includes review of permit information, 1 public hearing, and preparation for hearing
Substantial Amendments to Special Use Permit: **\$700.00**

• Requires public hearing and submittal of full application
Non-Substantial Amendments to Special Use Permit: **\$250.00**

- Not requiring a public hearing as determined by the PC Chair and Z.A.

Additional Flood Zone Permit Fee: ***

Primary Dwelling **\$1,000.00**

Detached accessory buildings or structures including detached decks **\$500.00**

Residential Solar & Wind Energy Installations: **\$250.00**

Land Use Permit Extensions: **\$10.00**

- Original permit may be extended for two one-year increments only
- Any subsequent request requires reapplication for a new land use permit including payment of the full fee prior to any further work on the project

Demolition Permit: **\$10.00**

- Permit expires after one year

Variance Request: **\$750.00 + Costs ******

Zoning Ordinance Amendment Request: **\$750.00 + Costs ******

- Any costs less than \$750.00 will have the over payment returned.

Land Division Request:

A Parcel Split	\$100.00
Each additional split (Subdivision areas are treated the same as land division)	\$50.00
